#### Labour warranty – 12 months

- The labour for the replacement of products and spare parts to which this warranty applies will be supplied by Seima or its authorised agent within one year from the date of purchase.
- The obligations of Seima under warranty are limited to the repair or, at the option of Seima, replacement of any products which are defective through faulty manufacture or materials. To the extent permitted by law, Seima will not be liable for any loss or damage to furniture, floor coverings, walls, fixtures or any other consequential loss of any kind caused by any defect in the product or components.
- Our goods come with guarantees that cannot be excluded under Australian Consumer Law. You are entitled to a replacement or refund for a major failure and for compensation for any other reasonably foreseeable loss or damage. You are also entitled to have the goods repaired or replaced if the goods fail to be of acceptable quality and the failure does not amount to a major failure.
- Should any warranty claim be made where, in the opinion of Seima, the problem was caused by faulty installation or a cause other than a manufacturing defect in the goods for which Seima is responsible, Seima reserves the right to charge a service fee.

### **IMPORTANT!**

Your warranty will be voided or limited for the following:

- Domestic use warranty only.
- Improper or unsuitable use or maintenance or cleaning.
- Transport knocks, scuffs, scratches, tampering.
- Incorrect repairs or repairs made by unauthorised technicians.
- Normal wear and tear.
- Non-compliance with technical, installation or care instructions.
- Water pressure exceeding 500 kpa (as per AS3000) or damage caused by not flushing water lines and/or foreign material in water lines.
- All relevant products must be installed by a licensed plumber
- Proof of purchase must be supplied. Limited to the first owner, start date taken from purchase or builder handover date (where handover is no more than 12 months from purchase date).
